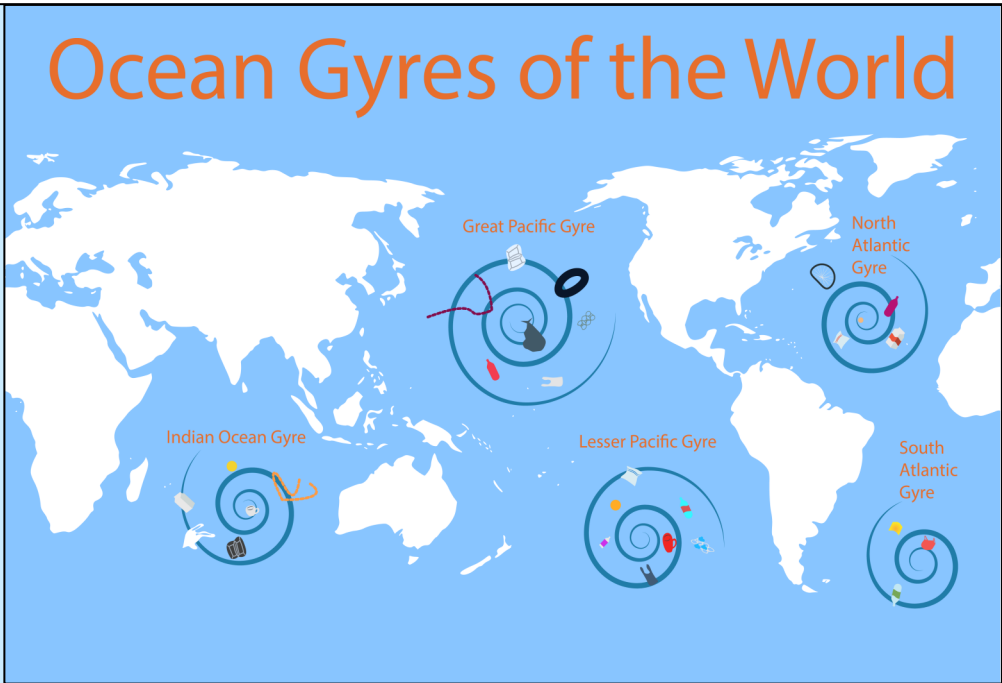

Willy is quite literally the son of a son of a sailor. He has logged 30,000nm sailing from the Indian Ocean, Red Sea, Gulf of Aden, Mediterranean, Atlantic, Pacific and the Southern Ocean, professionally and recreationally, as both captain and engineer (and a lot as deckie as well).

In May of 2020, just as Covid was starting to shut down the entire world, Willy embarked on one of his favorite voyages of all time onboard the sailing cargo ship SV Kwai. They sailed out to the middle of the North Pacific Gyre, also known as the “Great Pacific Garbage Patch”, and for seven weeks straight collected as many “Ghost Nets” and as much plastic debris as they could.

Returning to Honolulu with 103 tons of plastic waste recovered from the North Pacific Ocean, they set the world record for a single ocean clean-up operation!

Willy would love to share with you some of the most impactful photos from this journey, as well as the strategy, process, and insights gained from this experience, ultimately in hopes to raise awareness to the massive issue of Ghost Nets and plastic debris endangering our beautiful One Ocean.

Local Option Levy on November 7th
Ballot, Outdoor Burning Season Opens

Crooked River Ranch Fire & Rescue has Measure 16-107, a local option levy, on the November 7th ballot. This local option levy replaces an expiring levy. The new local option levy will help improve our ability to respond to the increasing call volume by retaining two grant-funded Firefighter/Paramedic positions and hiring a third. Over the last 10 years we have seen a 36% increase in call volume and of that increase 66% of those calls are for emergency medical services/ambulance transport. The funds from this local option levy will allow the District to improve service and meet our community’s needs. Outdoor debris burning opened for private properties within Crooked River Ranch on a day-to-day basis on Tuesday, October 3rd. Remember each day before doing any debris burning you must call the Burn Information Line at 541-923-4633 to find out if there are any restrictions in place. Download the Burning Regulations and Safe Debris Burning pamphlet and review it before you burn. For more information visit <https://www.crrfire.org/outdoor-burning>

In September CRRF&R responded to 51 calls for service. This included three (3) fire responses, forty-two (42) medical calls, and six (6) service/

good intent calls. Please remember if you have an emergency call 9-1-1, tell them you live on Crooked River Ranch and whether you have a medical or fire emergency. Always answer all the dispatchers’ questions, they will update us while we are responding.

Once again you can help make the holidays a little brighter for less fortunate families on the Ranch. This Holiday season, we will have our Giving Tree in the Fire Station lobby, with tags that have a person’s needs and wants. You can choose a tag *beginning November 27th*, purchase gifts for them within your budget, and bring them back (unwrapped) to the Fire Station by December 18th. We will wrap and distribute the gifts to the families for the Holidays. (see pg. 17)

Heritage House Historian, Barbara Lokting, puts her natural curiosity to good use

Meeting up with Barbara Lokting is a journey down memory lane and you better come prepared to see her array of notebooks, files pictures, maps and hear a history lesson about the pioneers and land settlers of Oregon. With just a bit of prompting, she is off and running with a deluge of stories about families with various fun and historical facts that eventually all form to create a great picture of who settled here in Central Oregon.

Lokting had a fascination with genealogy that began while researching into her own family of Oregon pioneers. While living in Portland, Oregon most of her life, she made friends with other like-minded descendants joining a group that met annually for their own pioneer reunions.

Following the death of her husband, she decided it best to join her daughter and son-in-law, Diane and Danny Nunley already living on the ranch. Relocating proved to be too removed for regular meet ups with her Portland pioneer friends, thus creating a big void in her life. It wasn't much later she became the tag-team to her daughter, Diane, in the historic restoration of the Heritage House. It renewed her *spark of natural curiosity* that got her once again on the sleuthing trail to learn as much as she could about the history of Crooked River Ranch and the Gates House, now known as the *Heritage House*.

On any given Tuesday, you can find Lokting managing the Heritage House library with her co-librarian, Evelyn Eads. They both intake books, categorize and file them all on the neatly lined shelves for anyone who wants to come looking for a good read. Also available are movies on DVD.

Spare yourself a few minutes and ask Barbara about the many families that either inhabited the Heritage House or owned the ranch, she's happy to tell you all about it. If you're lucky, you can also get a little tour of the Heritage House with all its interesting factoids and pictures associated with each room. Upstairs you'll

find two rooms set aside for the bride and groom and their accompanying parties as they ready themselves for a country wedding on the beautiful grounds.

Upstairs in what they call Dale's room, prominently sits the branded ZZ Cattle Ranch baseball cap in a display case. It was donated by a son of Thomas Bell, a previous owner, one year while visiting. Another room is dedicated to many other memorabilia and historical pictures. Quite often you can find any number of Crooked River Ranch groups holding their monthly meetings.

Culver resident and friend of Lokting, Sandra Ihrig, began a quest to put the Heritage House on the national register. While the Heritage House has been on the Oregon Heritage Register since 1976, together they are forging ahead the long and arduous journey of gathering all the necessary data so they can apply to the *National Register of Historic Places*.

But that is just the beginning. The National register is a comprehensive multi-page form comprised of documentation supporting facts, events, pictures, and firsthand accounts for consideration. Once it passes the local review boards, it moves on to the governor, then to Washington, D.C., where every detail is scrutinized. And that is where Lokting shines, and her notebooks come in handy. Besides tracking down previous ranch owners, they managed to track down and host previous family members who have actually lived in the Heritage House. All this documentation and recounting of the many firsthand stories of life on the ranch and actual events in the house puts Ihrig and Lokting much closer to formally applying for the coveted National Register Program.

While the function of the Heritage House and ranch has changed many times through the years from family to family, Lokting hopes to see that the beauty of the historical restoration of the Heritage House is not only appreciated locally but recognized nationally. Lokting can rightfully claim that she was a significant contributor to the last historic remodel as well as a historical documentarian. One thing for certain, however, is that Barbara Lokting will make sure the history remains intact.

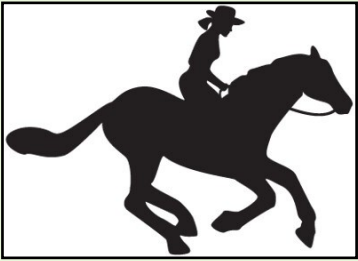

Crooked River Ranch horse happenings

Those little blue ETS signs! I'm sure many of you noticed the little blue ETS signs and wondered what ETS is. ETS stands for Equine Trail Sports, a laid-back competition hosted by Endurance riders Sharalyn Hay and Shawna Bowin. The first event was held in May of this year and the second Sept. 8-10. ETS has a pretty comprehensive website at www.equinetrailsports.com, and they also have a Facebook page.

Reports are that the event was well received and well attended. The competition was previously held in Sisters. When that venue was no longer available Sharalyn approached the CRR Board of Directors about using the Buffalo place area as the new venue. Approval was granted and that put Sharalyn, Shawna, and Sharalyn's husband, Richard, into action. They had to move all of the obstacles previously built by Richard from the Sisters location to Sharalyn's home, then, choose which ones to take to the new venue here on the ranch. Sharalyn says she has approximately seventy-five obstacles to choose from.

There were a little over thirty competitors, with seven camping for the weekend. It mostly consisted of local folks but a few did travel a fair distance to compete.

The course took about 2.5 hours to complete. Riders completed an obstacle at camp, then rode toward the senior center, completed an obstacle along the road, then on to the steel stampede to complete an obstacle, and on to the arena for 2 more obstacles, and then back to camp for the final obstacle. The weekend included two trail rides that were around four miles each that went along the rim with fantastic views of the mountains and the Crooked River.

The prizes included first through sixth place ribbons, for each of the three divisions: novice, intermediate, and advanced. The first-place winner in each division also received another prize, such as a latigo set with a bag of horse goodies (hoof pick, mane brush etc). I asked Sharalyn if ETS would be back in 2024, she told me unfortunately she and her co-host Shawna would not be able to host ETS due to a conflict with the National Endurance Championship being held in Central Oregon. Sharalyn, also said she had been approached by several folks that might be willing to take on the role of hosting a couple of ETS events in CRR, for 2024. Sharalyn really hopes it will happen for 2024, but she and Shawna will be back to host 2025!!

Crooked River Ranch Committees, Keeping Crooked River Ranch Running...

I want to take this opportunity to let our community know about the many generous people who take time out of their lives to support Crooked River Ranch on committees. All eight of our committees are seated with volunteers. The Architectural Review Committee (ARC) is the only committee in which the committee members are elected. The ARC reviews, analyzes and approves applications for all property improvements to comply with the architectural guidelines of our community. Their efforts help maintain the aesthetics and property values of the Ranch.

The CC&R Review Committee has the role of investigating CC&R violation complaints submitted. They adjudicate whether claims are valid or don't meet violation standards. This committee works closely with county code enforcement officer on problems that represent county code violations. This is all in addition to educating homeowners and renters regarding CC&Rs and county code requirements.

One of the summer season's most popular committees is Parks and Recreation. They provide two fun filled sessions in July for kids from kindergarten thru grade six. Activities include crafts, swimming lessons, pickleball, golf, soccer, and snacks. They end each session with a picnic in Mac Park. The other responsibility of this committee is to provide advisory input to the Board concerning issues related to park improvement and use.

The Events Planning Committee is responsible for the planning, coordination, and production of Board-sanctioned events on Crooked River Ranch. The EPC will promote participation in community events by residents and guests and will ensure all events are organized and conducted in a manner that reflects well on CRR. The committee will procure vendors, entertainers, and special interest groups for events. They coordinate with local businesses, sponsors, and volunteers to facilitate events including the Independence Day Celebration & Barn Dance, Western Holiday Village Christmas, Annual Yard Sale, Art Events, and more.

The distribution of information between the Board of Directors and the Ranch members and renters is the role of the Neighborhood Phase Rep Committee [NPRC]. Residents subscribe to the system to receive important emails providing notices of emergencies, events, meetings and more. Each Phase will have one or more representatives with approximately 24 total, if positions can be filled.

The Ranch Enhancements Committee utilizes the profits from the Steel Stampede event and other funding sources such as donations, for projects that benefit the Ranch as a whole, separate from the operating funds of the Ranch. Any CRR member in good standing can sponsor a Ranch project by submitting a Project Proposal Form. After the committee reviews the request, they will present the selected projects to the BOD for the Board's approval.

The mission of the Alternative Funding Committee is to create reliable non-revenue funding streams to be used for programs and services that promote the preservation and betterment of the Ranch and its residents. This committee has been successful in assisting the Lions Club in obtaining a grant to purchase fire abatement equipment which will be used on the Ranch.

The final committee would be The Budget Audit Committee [BAC]. This committee works with Ranch staff to create both an Operating and a Capital Reserve Plan budget. The process begins in October and the committee submits the budgets to the Board for its review and adoption in March of the following year. In addition, the BAC makes recommendations concerning the funding of the Capital Reserve Plan [CRP] from operating funds to the Board for review and implementation during the next fiscal year.

Crooked River Ranch committees make it possible to provide events and activities that engage our community and foster a sense of belonging. They ensure compliance with the CC&Rs, rules and regulations that help to maintain property values and quality of life. Volunteers are vitally important to the Ranch community as we rely on their time and efforts to continue to move forward. Grateful for those who choose to contribute is an understatement.

Defensible Space Tip of the Month



Weekend project idea! Look at your deck and make sure it is clear of anything that could catch fire like pine needles and other debris. Clean both above and below. Also, during times of high fire danger, remove patio furniture that could catch fire.

Thanksgiving is the leading day of the year for cooking fires and kitchen accidents.



While your first instinct might be to take a flaming pot or pan and put it in the sink, it's not safe. Here are a few tips for a safer way to react:

- 1) First, if it's a large fire get out – yell "fire" so everyone gets out and **call 911**.
- 2) Do NOT pour water on it. Water can cause splashes which would burn you and cause the fire to spread.
- 3) Baking soda can help put out small grease fires, but you need a lot of it. (Note: Do not use any other baking ingredients. Only BAKING SODA.)
- 4) Salt is a great absorber of heat for its volume. A moderate amount – about a cup – can help extinguish a decent size grease fire

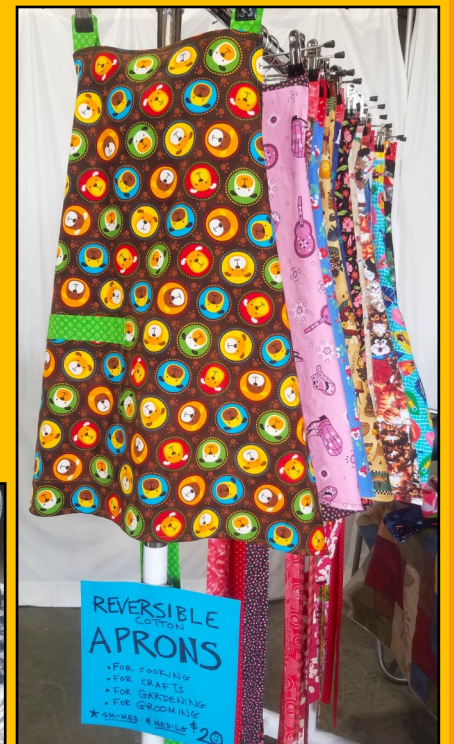

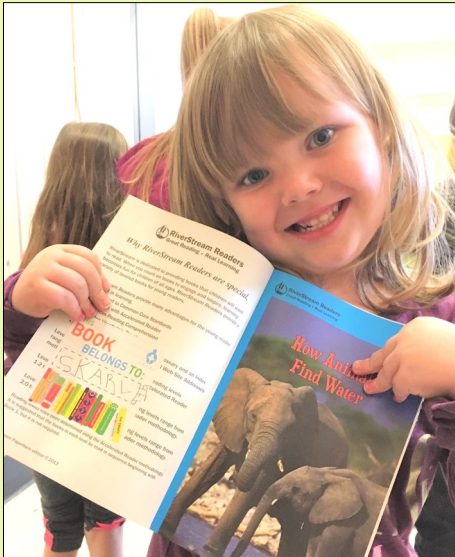

Record Breaking Kicker \$5.61 Billion (*with a B*) The kicker will be returned to taxpayers

Following the August 20th Revenue Forecast, the final numbers have been released and this will be the largest personal income kicker in Oregon History.

I have heard from many constituents during the session and the interim who are passionate about keeping the kicker. Know that I have always and will continue to adamantly support the kicker.

The Oregon Department of Revenue has shared the following information- The Oregon Office of Economic Analysis (OEA) has confirmed a revenue surplus of more than \$5.61 billion in the 2021-2023 biennium, triggering a tax surplus credit, or “kicker,” for the 2023 tax year. The surplus will be returned to taxpayers through a credit on their 2023 state personal income tax returns filed in 2024. The credit is based on tax liability for the 2022 tax year. Taxpayers who have not yet filed a 2022 tax return, should file now so they can claim their kicker credit when they file their 2023 tax return.

Personal income taxpayers can determine the amount of their kicker using a “*What’s My Kicker?*” calculator available on [Revenue Online](#). To use the calculator, taxpayers will need to enter their name, Social Security Number, and filing status for 2022 and 2023.

Taxpayers may also hand-calculate the amount of their credit, by multiplying their 2022 tax liability before any credits—line 22 on the 2022 Form OR-40—by 44.28 percent. This percentage is determined and certified by OEA. Taxpayers who claimed a credit for tax paid to another state would need to subtract the credit amount from their liability before calculating the credit.

How is the kicker returned to taxpayers?

The kicker will be returned to taxpayers through a credit on their 2023 state personal income tax returns that may be filed starting in 2024.

Taxpayers who have not yet filed a 2022 tax return – possibly making them eligible for a kicker - should do so, and pay any tax owed, so they can claim their kicker credit when they file their 2023 tax return.

Other important kicker information

The state may use all or part of a taxpayer’s kicker to pay any state debt they owe, such as tax due for other years, child support, court fines, or school loans.

Taxpayers may choose to donate their kicker to the Oregon State School Fund for K-12 public education using a checkbox on their return. The donation is for 100 percent of a taxpayer’s kicker and may not be revoked if selected.

Taxpayers may also choose to donate all or part of their kicker to any or all of the 29 charities approved by the Charitable Checkoff Commission. Taxpayers use Form OR-DONATE to designate any amount, or all of their refund, to donate to charity.

2024 Tax Filing Season

The filing season for 2023 Oregon Income Tax returns will open in mid-January 2024. The department will begin making any refund payments owed to taxpayers in mid-February 2024. The timing of return processing and refund payments will depend on the date filed by a taxpayer, completeness of a return, volume of returns, refund amount, and other factors. We look forward to serving taxpayers in this historic season.

- Thanksgiving has been an official holiday since the days of George Washington, who, in 1789, issued the first proclamation of Thanksgiving to honor the new national constitution.
- During the early 19th century, numerous states began to observe Thanksgiving on their own, setting different dates state by state.
- In the 1860s, Mrs. Sarah J. Hale, editor of Codey's Lady's Book, mounted a vigorous campaign for a national Thanksgiving Day to be on the same date each year, coast to coast.
- This gained presidential attention, and subsequently, on October 3 of 1863, Abraham Lincoln proclaimed the last Thursday of November as a National Day of Thanksgiving. We celebrated the official holiday together as a nation on November 26, 1863.
- For the next seven decades, each U.S. President issued his own proclamation confirming the date. Then, in 1939, Franklin D. Roosevelt re-set the day as November's third Thursday.
- But, in 1941, a resolution was made to change it to the fourth Thursday of November, and it has remained thus ever since.
