The Mystery of Deep-water Coral Reefs

Coral reefs are iconic ecosystems that support high biomass and diversity in the world's oceans. Did you know that there are cold-water coral reefs deep in the ocean with their own ecosystems? Join FANs for a presentation by Dr. Steve W. Ross, of recent discoveries from deep water surveys of cold-water coral mounds off the east coast of the United States. The presentation will be held February 18th from 4:00 p.m. to 6:00 p.m. in the Juniper Room at Crooked River Ranch.

Dr. Ross is a native of North Carolina and has spent most of his 35-year career in-

volved in marine science in the Atlantic basin. He earned a BS degree in zoology from Duke University, a MS degree from UNC-Chapel Hill, and a PhD from North Carolina State University. He was the Research Coordinator for the North Carolina Coastal Reserve Program for 13 years. Dr. Ross led offshore studies for the US Geological Survey for several years. He specializes in ichthyology (fishes), particularly the areas of ecology and life history studies (age, growth, feeding, reproduction). He has conducted numerous, diverse projects in rivers, estuaries and offshore waters, including over 45 cruises, many using submersibles and ROVs and for

Crooked River Ranch Crime Watch

December, 2022

There were 1150 county wide calls made to Jefferson County Sheriff Department in the month of December. CRR actions and calls for service: 318.

Of a total of 61 incidents in the Jefferson County Sheriff's Department **Press Log** for the period December 5, 2022, through January 1, 2023, six (6) involved Crooked River Ranch.

- On December 5, a Deputy with the Jefferson County Sheriff's Office was notified of a dog bite on SW Buckskin. The dog was not at large and has up to date vaccinations. A report was filed.
- On December 14, a Deputy with the Jefferson County Sheriff's Office received a cross examination report from DHS for an address in Crooked River Ranch. After speaking with the case worker from DHS, they will be closing the case unfounded.
- On December 16, Deputies from the Jefferson County

Sheriff's Office responded to a disturbance on SW Hayes Road. After an investigation, a person was arrested for Assault IV and Harassment. Thev were transported and lodged at the Jefferson County Jail without incident.

- On December 18, a Jefferson County Sheriff's Deputy investigated a DHS cross report from Crooked River Ranch. It was determined that it did not constitute a crime.
- On December 23, a Deputy with the Jefferson County Sheriff's Office received a cross examination report from DHS regarding allegations of abuse on Crooked River Ranch. The case was closed at screening by DHS.
- On December 23, a Deputy with the Jefferson County Sheriff's Office was dispatched to a call on SW Steelhead Rd regarding a package being stolen off a porch.



BOARD MEETING HIGHLIGHTS

January 16 2023

- The meeting was called to order by President Vickery. All Directors were present except for Director Jones.
- Consent items were approved by unanimous vote.
- Ranch Manager LaPora reported that payments continue to be made in the first month of the new semi-annual period, keeping the staff busy. She also gave a shoutout to Kara for her work on delinquent accounts. She is making a lot of headway.
- The exploration into the rebuilding of a new website continues. A list of wants and needs has been provided to the web designer and a contract proposal will be discussed during Executive Session. This will continue to take time.
- Supervisor Knoke reported that fire abatement projects are in the process of being prioritized and a timeframe will need to be created. He also noted that Wellspring Management, our fire abatement partner, will be reducing their workload in the future. We are working with Heart of Oregon to provide additional resources for fire abatement on both Association property and resident's properties.
- Ranch Manager LaPora reported that the Capital Reserve Plan budget is close to being completed. She is meeting with supervisors on Tuesday to discuss each department's operating budget. Wednesday's BAC meeting will review the first six months' financials.
- Vice President Erdekian provided a brief schedule of dates for first year steps for the CRR Community Garden. This includes fencing, soil turnover, fertilizing and watering.
- The Steel Stampede is scheduled for May 6 & 7, 2023. It will be a return to a full event, which includes the trials, races, vendors, and swap meet. Brenda Cooper has taken on coordination of the event and has already reached out to volunteers from previous years.
- A water leak was discovered in the Association rental 5 A/B duplex. The leak occurred on December 24 but was not discovered until December 28. An insurance adjuster has reviewed the damage. Quotes for repairs are being determined. All but the \$1,000 deductible will be covered by insurance.
- Director Beveridge provided a summary of five RV Park Reservations systems.
 They were all reviewed, and two companies have been chosen to give a demonstration. An update will be presented at the Work Session.
- A motion to approve volunteer service forms for Ben Johnson, Kriss Krzycki and Diana Shire were approved unanimously.
- A motion to adjourn to Executive Session for contract discussion was made and approved unanimously. The Regular meeting was adjourned at 7:17 p.m. The Executive Session was adjourned at 7:59 p.m. with no action taken.

Our H.O.A.

Happy New Year! This is the time of year when we try to start with a metaphorical clean slate. Many use this time for starting or stopping habits or activities to improve our health, wealth, and welfare. It's a time for resolutions, goals, and lists. We walk that extra flight of stairs, or save that extra bit of money by rounding up our checks when we enter them in our register. All of the above are worthy goals. This month we are talking about something often ignored or is taken for granted, until we lose it. Drum-roll please......... homeowners insurance. Not the sexiest subject, but expect 2023 to bring big changes to homeowner's insurance, and not the fun kind.

The increase in disasters have spurred a big overhaul in the homeowners insurance industry. Here in Central Oregon, we have everything from wildfires to volcano's and earthquakes to floods. And as boring a subject as homeowners insurance is, in 2023 this subject demands our attention and require us to be ever diligent. Here is what the experts are suggesting for a less stressful and yes, more boring, year.

Don't Be Late On Payments

Many of us have been a day late or even missed a premium payment. We received a lapse notice and quickly made it up and were reinstated. "Do *not* expect that to happen in 2023," industry leaders warn, "regardless of the reason you missed that payment." If you are canceled, or non-renewed due to late payment(s), the insurance company must give you 30 days notice. The best way to avoid cancellation is not to miss a payment and do what's recommended.

Don't Ignore Letters From Your Insurance Company

Lots of Oregonians are receiving letters giving them specific instructions on how to make a loss less likely from their insurance company, often concerning trees and branches overhanging roofs.

This increases the risk of a fire reaching your home as well as damage to the roof itself from the limbs and foliage. Don't ignore this or put it off for later. This requires immediate attention or you risk having your policy canceled. Best advise again is to do what is recommended.

Review When You Renew

This is a time to carefully not just read, but study your insurance policy. Some coverage's that were automatic may no longer be included as standard in your policy. Meet with your insurance company or agent at least once a year to review your policy. Make sure you understand the policy limits, exclusions, and deductibles. Taking time to review your policies will help make sure you have the right coverage to meet your needs.

Make A Home Inventory

You can find most of this information on the declarations page of your insurance policy. Each year, your insurance company sends a copy of the declarations page when it is time to renew. Follow these easy steps to start building your home inventory:

Step 1: Take photos of every room in your home. Pay close attention to what's on walls, in closets, and don't forget storage spaces such as the attic, shed, and garage. Try to group similar items together when taking pictures.

Step 2: Write a brief description of each item. Note the make, model, price, and other details that might help when filing a claim.

Save time with the Home Inventory Apps. Mobile apps can make creating your home inventory easier, and several insurance companies provide these apps for free. Download a mobile app to start building your personal property list.

Safeguard Financial Information

Prepare for disaster by safeguarding your financial information. Collect important documents, such as titles, deeds, and financial records.

Make copies or place them and your home inventory in a safe place to quickly grab if you need to escape an approaching fire. This will help save time, money, and stress during and after the wild-fire.

Create Defensible Spaces Around Your Home

Create defensible space around your home by removing dry leaves, dead brush, debris, and pine needles from yards and gutters. Trim trees away from homes, barns, and sheds, and place screens over open vents on homes. These tasks reduce the fuels that enable wildfires to spread and give firefighters more time to slow the blaze.

Last Resort Options When Canceled

One trend being seen in Oregon is that property owners' premiums are increasing at alarming rates, or worse, being dropped by their insurer! Homeowners may then be unable to find any company that will cover them for a home owners policy. There is a last resort to turn to in Oregon. It's called The Oregon FAIR plan. The plan is operated through a non-profit association and serves as a last resort if a property owner can't find insurance coverage in the standard market

CRR RV Park to get a dump station



The Ranch's RV Park will have an RV dump station soon. The photos show the holding tanks being put in place near the 'D' Loop in the park. They will have the capability to hold almost six thousand gallons. An alarm system will alert the park when the tanks are nearly full so a truck can be called in to pump out the tanks and haul the septage away. There will be no need for a drain field or septic system. Since an average RV's holding tank capacity is 20 to 40 gallons, it is anticipated the holding tanks will only need to be emptied several times during the peak season. A credit card payment system will be provided to facilitate collecting fees.



2022 was a busy year for the fire district. We responded to a total of 613 calls for service. Of those calls 464 were for emergency medical services, 20 were related to fire suppression, and 129 were a combination of non-emergency services, good intent calls, and false







CRR Lions vision screeners go back to school

CRR Lions Club vision screeners went back to school for the final time this year when they screened students at Buckingham Elementary in Bend on January 19th. This screening concluded a five month effort that began in early September and ended with over 14,000 elementary and middle school students being screened in Central Oregon and surrounding areas. In addition to screening students in Bend-La Pine, Redmond, Sisters and Jefferson County School districts, screeners ventured to outlying areas such as Burns, Condon, Mitchell, Moro, Lakeview, Monument and Dayville.

"Vision screening is so important because if a child can't see, they can't learn," stated Screening Events Coordinator Jon Awbrey. "We're seeing a higher referral rate now than before Covid. In School Year 2019-20 the average area referral rate was 10%. Now it's closer to 16%, so it's extremely important to be back in the schools."

Eleven CRR Lions vision screeners were joined by Lions from La Pine, Bend and Sisters. "It really is an area effort," stated Awbrey. Through this collegial effort members of different clubs work together throughout the fall and into winter and are jointly able to screen large numbers of students.

Central Oregon Lions join a statewide program in which Lions of Oregon, in partnership with the Oregon Lions Sight & Hearing Foundation (OLSHF), will screen just over 170,000 school children this year. Considered a premier national program, the School Vision Screening (SVS) program was recognized by Lions Kid Sight USA for screening the most children in the nation during the time period from September through December 2021. "While it's great to be recognized nationally, the most important thing is that we're catching vision problems early, which can change the entire trajectory of a child's educational experience," stated former OLSHF Board Chair Phyllis Carlin.

In addition to the important work the screeners do, it's also fun. "I love going to these small rural schools," stated Carlin. "One of my favorite memories this year was being invited to have lunch with the first graders at Monument after screening. It just doesn't get any better than that!"

Well-intentioned people often feed deer, elk and other wildlife without realizing the problems feeding can create:

- Artificial feeding concentrates wildlife, which leads to the easier spread of disease and parasites and easier take by predators.
- Feeding deer and elk attracts their natural predators like cougars and coyotes to areas of human activity.
- Once wildlife associate people with giving them food, they come to expect it. Feeding will invite
 more deer and elk to your property and encourage them to stay.
- Artificial feeding can cause deer and elk to become habituated to humans and aggressive towards them.
- Concentrating deer and elk in human-settled areas can lead to an increase in vehicle collisions and conflicts between wildlife and pets.
- Concentrating deer and elk can hurt habitat by encouraging excessive grazing.

Every year, ODFW also sees seemingly healthy deer and elk die because they have been fed the wrong food by well-intentioned people. Their diet requirements actually change with the seasons and are best met by native forage. Deliberately feeding deer or elk may inhibit digestion and lead to death by starvation or infection.

ODFW does feed deer and elk at several wildlife areas during the winter, to keep them off adjacent agricultural lands where they damage crops. These feeding programs are long-term commitments that require significant financial and staffing resources. Feeding starts early in the season so deer and elk's digestive systems do not have to quickly readjust to new food types, and continues every day, no matter what, until forage conditions improve. Feeding areas are located away from human-populated areas to decrease conflicts. ODFW also conducts disease testing at some feeding sites.

Wildlife of the Month.....

North American Beaver

Oregon has long been known as the Beaver State due to the great economic benefit of the beaver fur trade, which preceded statehood. The state officially recognized the beaver as its state symbol in 1969. Biologists estimate a population of around 400 million beavers in North America before the settlement of Oregon. The fur trade decimated the beaver population almost to extinction. Protection efforts helped restore their numbers to a current estimated population of 15 million healthy individuals.

Popular myth claims that beavers destroy trees and vegetation around the ponds created by their dams' engineering. The truth is that beaver ponds create thriving ecosystems that encourage a healthy diversity of plant and animal life. Rivers and streams flowing through beaver ponds have higher water clarity and less pollution than those without ponds. Beavers cut trees with their strong, large teeth and drag them to place in the stream or river to effectively block the water flow. They build stick lodges packed with mud in the middle of the pond with underwater entrances to protect themselves from predators.

The American Beaver is the largest rodent in North America. They weigh an average of 40 pounds

but continue to grow during their lifetime and can reach 65 pounds. Their orange teeth grow constantly which balances against wear from chewing wood. They reach maturity at around 3 years of age and females have only one litter of kits per year with one to four kits. The parents live inside their lodges with both the new kits and those born the previous year.

Beavers are nocturnal and herbivorous, eating vegetation and wood. They do not eat fish. Beavers are neither friendly nor aggressive, but they will protect their territory from predators. If attacked by predators, including dogs, beavers will use their strong sharp teeth and front paws to drive away danger. Take care walking along our Deschutes and Crooked Rivers to avoid the traps that may be placed in the water. Trapping is still legal in Oregon for many furred animals and traps inadvertently injure dogs at times.

As you are meandering our riverbanks, look for the telltale tree stumps that have been cut into a cone; they most definitely indicate the work of our native North American Beavers.

Did you know that we have approximately 90 miles of roads on Crooked River Ranch. Out of the 90 miles of roads, 12 are County roads and 78 are Association roads. Of the 78 miles of Association roads, just over 26 miles are paved. All county roads are paved.

There are things we can all do to maintain and protect our roads. With winter around the corner, let's take a minute to think about ways to keep our roads passable and in good condition during inclement weather.

SLOW DOWN! Speed increases wash-boarding and unnatural erosion of our roads.

Do not abandon vehicles during inclement weather. Our equipment cannot effectively work around abandoned vehicles. When vehicles are left on the side of the road or blocking the entrance of a road or cul-de-sac, you are making it difficult, if not impossible, for the Road Department to plow.

Limit jack-rabbit starts and hard braking. This too damages our roads.

Remember that your Road Department is doing the best they can to keep your roads safe and drivable. With the vast number of road miles, your help is much appreciated. Be a good neighbor. Help where you can. Those who help by plowing cluster box areas and cul-de-sacs free our Road Department up to focus on the primary and secondary roads. Thank you to those who lend a hand. PLEASE SLOW DOWN!



Horses are high-flight prey animals. They are NOT big dogs!

If you encounter a horse on roads or trails, please adhere to the following for your safety and the safety of rider/horse:

- * If you're driving on a road and you encounter horses, please slow down. A horse can bolt sideways at 45mph and most often are frightened INTO the road.
- * If you're walking, biking, or running on a trail, please stop, speak to the rider and ask how they would prefer you proceed. Horses legally have right of way on most trails.
- * If you have children with you and you encounter a horse, please be sure your children remain still. Talking to the rider as they approach will help their horse understand you're no threat.
- * If you approach from behind, please communicate your presence as soon as you're able. Horses are much more likely to become fearful if you are suddenly running or riding up to their hind

end. And always keep a healthy distance when passing behind or to the side of a horse, for your own safety.




